From the Director of Quality Assurance:

FALSE CLAIMS ACT (FCA) - a company is prohibited from discharging, demoting, suspending, threatening, harassing or discriminating against any employee because of lawful

acts done by the employee on behalf of the employer because the employee testifies or assists in an investigation of the employer. Requires 1. Written policies for all employees and contractors that provide detailed information about the FCA, 2. Outline administrative remedies for false claims and statements, and 3. Educate employees about Whistleblower protection
